

Terms of Service — Balalayka

These Terms of Service ("Terms") govern the use of the Balalayka application and related services ("Service"). By creating an account or using Balalayka, you agree to these Terms.

If you do not agree with these Terms, you must not use the Service.

1. Description of the Service

Balalayka is a communication and productivity application that allows users to:

- exchange private messages
- participate in group chats
- share files, media, and documents
- create tasks from messages
- store notes and discussion items
- search across conversations

Balalayka is a public consumer application and is not restricted to a specific organization, employer, or institution.

2. Eligibility

You must be at least **13 years old** to use the Service.

By creating an account, you confirm that:

- you meet the minimum age requirement
 - the information you provide is accurate
 - you will comply with these Terms and applicable laws

3. User Accounts

To access certain features of Balalayka, you may need to create an account.

You are responsible for:

- maintaining the confidentiality of your account credentials

- notifying us immediately of any unauthorized use of your account

We reserve the right to suspend or terminate accounts that violate these Terms.

4. Acceptable Use

You agree not to use Balalayka to:

- violate any law or regulation
- distribute spam or malicious software
- harass, threaten, or abuse other users
- upload illegal or harmful content
- attempt to gain unauthorized access to systems or accounts
- interfere with the operation or security of the Service

We may remove content or restrict access if these rules are violated.

5. User Content

You retain ownership of the content you create and share through Balalayka, including messages, files, and other materials.

By using the Service, you grant Balalayka a limited license to:

- store your content
- transmit your content to intended recipients
- process the content as necessary to operate the Service

Balalayka does not claim ownership of user content.

6. Prohibited Content

Users may not share content that:

- violates intellectual property rights

- contains malware or harmful code
- contains unlawful material

Balalayka may remove such content and suspend associated accounts.

You may stop using the Service at any time.
